CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LEO R. BARCLAY 13549 FIELD-DENIO ROAD FIELDS, OREGON 97710

confirms the right to use the waters of WELL #1 in the TROUT CREEK BASIN for IRRIGATION OF 138.2 ACRES.

This right was perfected under Permit G-2706. The date of priority is JUNE 25, 1964. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.73 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW 1/4 SW 1/4, SECTION 16, TOWNSHIP 41 SOUTH, RANGE 35 EAST, W.M.; 50 FEET NORTH AND 50 FEET EAST FROM THE SW CORNER OF SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
