## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

UKIAH LUMBER COMPANY, INC. PENDLETON, OREGON

confirms the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for the IRRIGATION OF 8.0 ACRES, DOMESTIC, STOCK USE AND OPERATION OF A LOG POND.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 127. The date of priority is 1905.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.69 CUBIC FOOT PER SECOND (cfs), subject to the provisions of paragraph 33 of said decree, being 0.10 cfs for irrigation, domestic and stock use, 0.59 cfs for the operation of a log pond and that the quantity of water used for the operation of the log pond shall be limited to the duty of water fixed for irrigation purposes by said decree or such pro rata part thereof as is available between March 1 and November 1 of each year, measured at the point of diversion from the source.

The point of diversion is located as follows:
