## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STEWART LIVESTOCK COMPANY, INC. BY SARAH STEWART, PRESIDENT DAYVILLE, OREGON

confirms the right to use the waters of the JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 184.7 ACRES, DOMESTIC, AND STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for GRANT County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at Page 461. The date of priority is 1870 - TRACT 1, 1872 - TRACT 2, AND 1906 TRACT 3.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed ONE-FORTIETH of one cubic foot per second per acre irrigated from April 1 to September 30; further limited to 1.0 acre-foot per acre per calender month to July 1 and ½ acre-foot per acre thereafter; total 5.0 acre-feet per acre for season, measured at points of diversion, or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

TRACT 1 - HOME RANCH DITCH

TRACT 2 - ALDRICH DITCH

TRACT 3 - H.D. STEWART DITCH.

The amount of water used for irrigation, together with the amount secured under any other right for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre irrigated from April 1 to September 30; further limited to 1.0 acre-foot per acre per calender month to July 1 and ½ acre-foot per acre thereafter; total 5.0 acre-feet per acre for season, measured at point of diversion.

A description of the place of use to which this right is appurtenant is as follows:
