This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, said decree entered of record at Salem in the Order Record of the State Engineer in Volume 14 Page 498. The date of priority is SEPTEMBER 14, 1899. This right is limited to 1.56 CUBIC FEET PER SECOND (CFS), or its equivalent in case of rotation, measured at the head of the ditch or the point where the same leaves the natural stream, from April 1st to October 1st of each year.
