THIS CERTIFICATE ISSUED TO

MELVIN F & ROSALIND O. HOOVER & OREGON STATE GAME COMMISSION MEDFORD, OREGON 97501

confirms the right to use the waters of

NORTH AND SOUTH FORKS LITTLE BUTTE CREEK, tributaries of LITTLE BUTTE CREEK for MAINTENANCE OF SIX PONDS FOR WILDLIFE, RECREATION, AND FISH CULTURE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, said decree entered of record at Salem in the Order Record of the State Engineer in Volume 14 Page 498. The date of priority is SEPTEMBER 14, 1899. This right is limited to 0.41 CUBIC FEET PER SECOND (CFS), or its equivalent in case of rotation, measured at the head of the ditch or the point where the same leaves the natural stream, from April 1st to October 1st of each year.

The points of diversion are located at:

NORTH FORK: 40 FEET NORTH AND 620 FEET WEST FROM E 1/4 CORNER OF SECTION 20, being within the SE 1/4 NE 1/4 of Section 20, Township 36 South, Range 2 East, W.M.,

SOUTH FORK: 780 FEET SOUTH AND 400 FEET WEST FROM E 1/4 CORNER OF SECTION 29, being within the NE ¼ SE ¼ of Section 29, Township 36 South, Range 2 East, W.M.

A description of the place of use to which this right is appurtenant is as follows:

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.
