CERTIFICATE OF WATER RIGHT

This Certificate issued to:

ANTON P. PIETROK 9295 HOPEWELL ROAD NW SALEM, OR 97304

Confirms the right to use the waters of WILLAMETTE RIVER, a tributary of the COLUMBIA RIVER, in the WILLAMETTE BASIN for IRRIGATION OF 166.1 ACRES. This certificate describes that portion of the water right confirmed by Certificate 52400, State Record of Water Right Certificates, NOT modified by conserved water application C-3.

This right was perfected under Permit 35203. The date of priority is JUNE 10, 1970. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.75 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source: Lot 4 (SW½ SW½), Section 4, Township 6 South, Range 3 East, W.M.; 850 feet North and 60 feet East from SW Corner Section 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2 ½ ACRE-FEET PER ACRE for each acre irrigated during the irrigation season of each year and shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant is as follows:
