CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

Jeld-Wen Inc.
PO Box 5079
Klamath Falls OR 97601

confirms the right to use the waters of a WELL in the KLAMATH BASIN for IRRIGATION of 272.3 ACRES.

This right was perfected under Permit G-8576. The date of priority is May 11, 1979. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 3.40 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE~~X~~ NW~~X~~ Section 25 T37S, R11.5E, W.M., 900 feet North and 50 feet West of Center Quarter corner, Section 25.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

TOWNSHIP 37 SOUTH, RANGE 11.5E, W.M.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This use may be regulated if analysis of data available discloses that the appropriation will measurably reduce the surface water flows necessary to maintain the free-flowing character of a scenic waterway in quantities necessary for recreation, fish and wildlife in effect as of the priority date of this right or as those quantities may be subsequently reduced.

This certificate describes that portion of the water right confirmed by Certificate 53851, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered MAR 30 2004, approving Transfer Application 7748.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
