CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CITY OF KLAMATH FALLS

confirms the right to use the waters of WELL NO.'S 6, 7, 8 AND 10 in the LINK RIVER (UPPER KLAMATH LAKE) BASIN for MUNICIPAL USE.

This right was perfected under Permit G-1541. The date of priority is FEBRUARY 15, 1960. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 12.2 CUBIC FEET PER SECOND(CFS); BEING 1.8 CFS FROM WELL NO. 6, 3.6 CFS FROM WELL NO. 7, 5.8 CFS FROM WELL NO. 8 AND 1.0 CFS FROM WELL NO. 10, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL NO. 6 - LOT 8 (SW 1/4 NW 1/4), SECTION 32, TOWNSHIP 38 SOUTH, RANGE 9 EAST, W.M.; 2245 FEET SOUTH AND 1320 FEET EAST FROM THE NW CORNER OF SECTION 32;

WELL NO. 7 - LOT 8 (SW 1/4 NW 1/4), SECTION 32, TOWNSHIP 38 SOUTH, RANGE 9 EAST, W.M.; 2080 FEET SOUTH AND 1128 FEET EAST FROM THE NW CORNER OF SECTION 32;

WELL NO. 8 - LOT 8 (SW 1/4 NW 1/4), SECTION 32, TOWNSHIP 38 SOUTH, RANGE 9 EAST, W.M.; 2260 FEET SOUTH AND 1080 FEET EAST FROM THE NW CORNER OF SECTION 32; AND

WELL NO. 10 - LOT 8 (SE 1/4 NW 1/4), SECTION 32, TOWNSHIP 38 SOUTH, RANGE 9 EAST, W.M.; 222 FEET NORTH AND 1401 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 32.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

Water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).


When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered JUNE 21, 1991, and supersedes Certificate 32193, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
