confirms the right to use the waters of ONE WELL in the PUDDING RIVER BASIN for IRRIGATION OF 56.0 ACRES.

This right was perfected under Permit G-11494. The date of priority is JULY 19, 1990. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.7 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 SE 1/4, SECTION 21, TOWNSHIP 5 SOUTH, RANGE 1 WEST, W.M.; 2500 FEET NORTH AND 2000 FEET WEST FROM THE SE CORNER OF SECTION 21.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

When required by the Department, the water user shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The Department may require water level or pump test results every ten years.

Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

The right to the use of the water for the above purpose is restricted to beneficial use without waste on the lands or place of use described. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
