## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of TROUT CREEK, a tributary of Deschutes River, for IRRIGATION of 60.91 acres, DOMESTIC, and STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jefferson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 5, at Page 57. The dates of priority are 1885 and 1886. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 1.5 ACRE-FEET PER ACRE DURING ANY PERIOD OF 30 DAYS OR 6 ACRE-FEET PER IRRIGATION SEASON (IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION AT THE HEALY AND COMPANY DITCHES) or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

DIVERSION POINT #2 - NE¼ NW¼, SECTION 3, TOWNSHIP 9 SOUTH, RANGE 15 EAST, W.M., 42 FEET SOUTH and 2232 FEET EAST of the NW CORNER of SECTION 3.

JOHNSON GALLERY - SW $\frac{15}{4}$  NW $\frac{15}{4}$ , SECTION 3, TOWNSHIP 9 SOUTH, RANGE 15 EAST, W.M., 2622 FEET SOUTH and 399 FEET EAST of the NW corner of SECTION 3.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:
