CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL NO. 1 AND 2 in the TROUT CREEK BASIN for IRRIGATION OF 138.2 ACRES.

This right was perfected under Permit G-2706. The date of priority is JUNE 25, 1964. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.73 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL NO. 1 - SW 1/4 SW 1/4, SECTION 16, TOWNSHIP 41 SOUTH, RANGE 35 EAST, W.M.; 50 FEET NORTH AND 50 FEET EAST FROM THE SW CORNER OF SECTION 16; AND

WELL NO. 2 - SW 1/4 SW 1/4, SECTION 16, TOWNSHIP 41 SOUTH, RANGE 35 EAST, W.M.; 10 FEET NORTH AND 1150 FEET EAST FROM THE SW CORNER OF SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SW 1/4	13.5 ACRES
NW 1/4 SW 1/4	13.5 ACRES
SW 1/4 SW 1/4	40.0 ACRES
SE 1/4 SW 1/4	40.0 ACRES
NW 1/4 SE 1/4	7.9 ACRES
SW 1/4 SE 1/4	23.3 ACRES

SECTION 16

TOWNSHIP 41 SOUTH, RANGE 35 EAST, W.M.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This certificate is issued to describe that part of the right not involved in this change and confirms a change in PLACE OF USE approved by an order of the Water Resources Director entered SEPTEMBER 30, 1977, and supersedes Certificate 36755, State Record of Water Right Certificates.

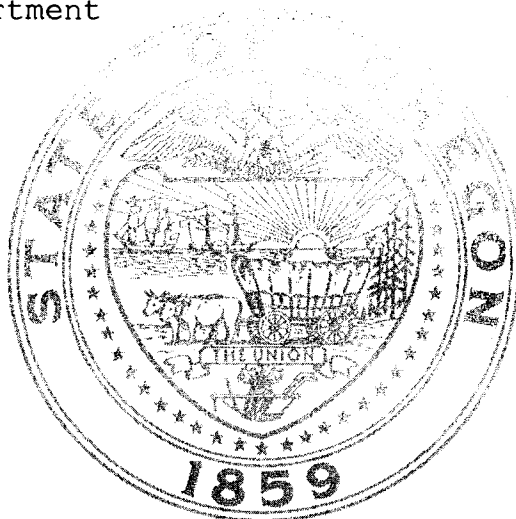
The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
