confirms the right to use the waters of A WELL in the YAMHILL RIVER BASIN for IRRIGATION OF 92.9 ACRES.

This right was perfected under Permit G-11886. The date of priority is JANUARY 6, 1994. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.16 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 NW 1/4, AS PROJECTED WITHIN D. SMITH DLC 78, SECTION 30, TOWNSHIP 4 SOUTH, RANGE 3 WEST, W.M.; 820 FEET SOUTH AND 700 FEET WEST FROM THE SW CORNER OF A. AND P. SMITH DLC 48.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

Measurement, recording and reporting conditions:

- A. The water user shall install a meter or other suitable measuring device as approved by the Director. The water user shall maintain the meter or measuring device in good working order.
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.
- C. The Director may require the water user to keep and maintain a record of the amount (volume) of water used and may require the water user to report water use on a periodic schedule as established by the Director. In addition, the Director may require the water user to report general water use information, the periods of water use and the place and nature of use of water under the right. The Director may provide an opportunity for the water user to submit alternative reporting procedures for review and approval.

The Department may require water level or pump test results every ten years.

Failure to comply with any of the provisions of this right may result in action including, but not finited to restrictions on the use, civil penalties, or cancellation of the thinks.

The right to the use of the water for the above purpose is restricted to beneficial use without waste on the lands of place of use described. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
