confirms the right to use the waters of SEVEN MILE CREEK, for IRRIGATION OF 218.6 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for KLAMATH COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 12, at Page 269. The date of priority is 1890.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1/50th of one CUBIC FOOT PER SECOND per acre irrigated prior to July 20<sup>th</sup> and 1/80th of one CUBIC FOOT PER SECOND per acre irrigated thereafter, and shall not exceed 5 acre feet per acre during irrigation season from April 1<sup>st</sup> to October 1<sup>st</sup> of each year.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SE 1/4 39.3 ACRES  
NW 1/4 SE 1/4 39.3 ACRES  
SW 1/4 SE 1/4 15.0 ACRES

THE DECREE IS OF RECORD AT SALEM, IN THE ORDER RECORD OF THE WATER RESOURCES DIRECTOR, IN VOLUME 12, AT PAGE 269. THIS CERTIFICATE SUPERSEDES CERTIFICATE 10913.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
