CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WELLS NO.'S 1 THROUGH 7 in the SIUSLAW RIVER BASIN for MUNICIPAL USE.

This right was perfected under Permit G-3040. The date of priority is SEPTEMBER 16, 1965. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.0 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL 1 - NW 1/4 SE 1/4, SECTION 23, T 18 S, R 12 W, W.M.; 2060 FEET NORTH AND 4060 FEET EAST FROM THE SOUTH 1/4 CORNER OF SECTION 23;

WELL 2 - NW 1/4 SE 1/4, SECTION 23, T 18 S, R 12 W, W.M.; 3595 FEET SOUTH AND 2075 FEET WEST FROM THE NE CORNER OF SECTION 23;

WELL 3 - NW 1/4 SE 1/4, SECTION 23, T 18 S, R 12 W, W.M.; 3740 FEET SOUTH AND 1625 FEET WEST FROM THE NE CORNER OF SECTION 23;

WELL 4 - NW 1/4 SE 1/4, SECTION 23, T 18 S, R 12 W, W.M.; 3250 FEET SOUTH AND 1540 FEET WEST FROM THE NE CORNER OF SECTION 23;

WELL 5 - SW 1/4 NE 1/4, SECTION 23, T 18 S, R 12 W, W.M.; 1600 FEET SOUTH AND 1870 FEET WEST FROM THE NE CORNER OF SECTION 23;

WELL 6 - SW 1/4 NE 1/4, SECTION 23, T 18 S, R 12 W, W.M.; 2120 FEET SOUTH AND 1890 FEET WEST FROM THE NE CORNER OF SECTION 23;

WELL 7 - NW 1/4 SE 1/4, SECTION 23, T 18 S, R 12 W, W.M.; 2620 FEET SOUTH AND 1905 FEET WEST FROM THE NE CORNER OF SECTION 23.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.


