## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

C. W. HARROLD GRANTS PASS, OREGON 97526

confirms the right to use the waters of a DRAINAGE CHANNEL, a tributary of ROGUE RIVER, for IRRIGATION OF 0.83 ACRES and SUPPLEMENTAL IRRIGATION of 1.34 ACRES.

This right was perfected under Permit 9511. The date of priority is FEBRUARY 24, 1930. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.026 CUBIC FOOT PER SECOND (cfs); being 0.01 CFS for IRRIGATION and 0.016 cfs for SUPPLEMENTAL IRRIGATION, or the equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
