CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RON LA FRANCHI
580 N. CENTRAL
COQUILLE, OREGON 97423

confirms the right to use the waters of WELLS 4 AND 5 in the CHRISTMAS VALLEY BASIN for PRIMARY IRRIGATION OF 396.2 ACRES AND SUPPLEMENTAL IRRIGATION OF 456.4 ACRES.

This right was perfected under Permit G-8551. The date of priority is FEBRUARY 8, 1979. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 5.65 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

- Well 4: NE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 23, TOWNSHIP 26 SOUTH, RANGE 15 EAST, W.M.;
1310 FEET SOUTH AND 2530 FEET EAST FROM THE NW CORNER OF
SECTION 23; AND
- WELL 5: NE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 23, TOWNSHIP 26 SOUTH, RANGE 15 EAST, W.M.;
1330 FEET NORTH AND 1330 FEET EAST FROM THE SW CORNER OF
SECTION 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


The water user shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

This certificate describes that portion of the water right confirmed by Certificate 76519 State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JUN 23 2004, approving Transfer Application 9273.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
