CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RON LA FRANCHI

confirms the right to use the waters of TWO WELLS in the FORT ROCK BASIN for IRRIGATION OF 456.4 ACRES.

This right was perfected under Permit G-7480. The date of priority is MAY 4, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 4.21 CUBIC FEET PER SECOND (CFS), BEING 2.54 CFS FROM WELL #1 AND 1.67 CFS FROM WELL #6 or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

- WELL 1: SE 1/4 SW 1/4, SECTION 22, TOWNSHIP 26 SOUTH, RANGE 15 EAST, W.M.; 1120 FEET NORTH AND 1650 FEET EAST FROM THE SW CORNER OF SECTION 22; AND  
WELL 6: NW 1/4 NW 1/4, SECTION 22, TOWNSHIP 26 SOUTH, RANGE 15 EAST, W.M.; 1260 FEET SOUTH AND 1300 FEET EAST FROM THE NW CORNER OF SECTION 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
