## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELTON MUILENBURG 10305 S "C" STREET ISLAND CITY, OREGON 97850

confirms the right to use the waters of the GRANDE RONDE RIVER, a tributary of the SNAKE RIVER, for IRRIGATION OF 119.1 ACRES.

This right was perfected under Permit 31353. The date of priority is FEBRUARY 17, 1966. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.98 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE¼ SE¼, SECTION 34, T 2 S, R 38 E, W.M.; 500 FEET NORTH AND 575 FEET WEST FROM THE SE CORNER OF SECTION 34

SE¼ SW¼, SECTION 35, T 2 S, R 38 E, W.M.; 685 FEET NORTH AND 2628 FEET EAST FROM THE SW CORNER OF SECTION 35.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.
