CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT W. BRADSHAW  
3820 RIVERHAVEN DR.  
PASCO, WASHINGTON 99301

confirms the right to use the waters of COLUMBIA RIVER, a tributary of PACIFIC OCEAN, for IRRIGATION OF 946.2 ACRES.

This right was perfected under Permit 36169. The date of priority is MARCH 13, 1972. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 19.34 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 7, T. 5 N., R. 30 E., W.M., 460 FEET NORTH AND 1680 FEET EAST FROM THE SW CORNER, SECTION 7.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
