CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JACKSON FAMILY FARMS LLC
P.O. BOX 10163
PORTLAND, OR 97210

confirms the right to use the waters of Jackson Well No. 1 in the OAK CREEK BASIN for IRRIGATION of 57.3 acres.

This right was perfected under Permit G-2375. The date of priority is March 12, 1963. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.71 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within McKnight DLC 57, Section 12, T12S, R3W, W.M.; 990 feet North and 1060 feet West from the NW Corner of Gilmore DLC 85.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



This certificate describes that portion of the water right confirmed by Certificate 36656 , State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JUN 17 2004 , approving Transfer Application 8249.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
