confirms the right to use the waters of the CROOKED RIVER, a tributary of the DESCHUTES RIVER for the purpose of LIVESTOCK, DOMESTIC, and IRRIGATION of 88.7 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for Crook County, the said decree entered at Salem, in the Order Record of the Water Resources Director, in Volume 1 at Page 449. The date of priority is 1891. This right is limited to an amount actually beneficially used, and shall not exceed a reasonable amount for stock and domestic use, and 1.48 CFS for irrigation, or its equivalent in case of rotation, measured at the point of diversion from the source. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The point of diversion is located as follows:
