## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WHITE DEER RANCH C/O J. FREEDMAN 15 SW COLORADO BEND OR 97702 BOBBY KENNEDY 2750 SOUTH CROOKED RIVER HWY PRINEVILLE OR 97754

confirms the right to use the waters of the CROOKED RIVER and PRINEVILLE RESERVOIR constructed under Permit R-2223, tributaries of the DESCHUTES RIVER, for IRRIGATION of 14.8 ACRES and SUPPLEMENTAL IRRIGATION of 65 ACRES.

This right was perfected under Permit S-25991. The date of priority is APRIL 8, 1914. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.99 CUBIC FEET PER SECOND (if available at the original point of diversion at Bowman Dam and People's Ditch diversion described as being located within the NW¼ SW ¼, SECTION 8, TOWNSHIP 15 SOUTH, RANGE 16 EAST, W.M.; 1920 FEET NORTH and 340 FEET EAST from the SW CORNER, SECTION 8), or its equivalent in case of rotation, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. The use of stored water under this right is subject to the water user having a contract for the stored water between the Bureau of Reclamation, or owners of the reservoir, and the water user.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:

When required by the Department, the water user shall install and maintain headgates, an in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction, and shall be installed under the general supervision of the Department.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
