## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ANDREW EDER 12730 MILLER RD NE GERVAIS, OR 97026

confirms the right to use the waters of PUDDING RIVER, a tributary of the WILLAMETTE RIVER, for SUPPLEMENTAL IRRIGATION of 50.9 ACRES.

This right was perfected under Permit 33378. The date of priority is March 13, 1968. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.64 CUBIC FOOT PER SECOND, or the equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second or the equivalent for each acre irrigated, and a total diversion not to exceed 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183,484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183,484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.
