CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DON ROSHAK 13580 SW ROY ROGERS RD SHERWOOD, OR 97140

confirms the right to use the waters of AN UNNAMED STREAM, A TILE LINE AND RESERVOIR CONSTRUCTED UNDER PERMIT R-8181, tributaries of TUALATIN RIVER, for IRRIGATION of 0.86 ACRE, and SUPPLEMENTAL IRRIGATION of 2.54 ACRES.

This right was perfected under Permit 45190. The date of priority is JANUARY 31, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.04 CUBIC FOOT PER SECOND (cfs); BEING 0.01 cfs for IRRIGATION and 0.03 cfs for SUPPLEMENTAL IRRIGATION, or the equivalent in case of rotation, measured at the point of diversion from the source. THE USE OF WATER IS LIMITED TO STORED WATER ONLY DURING THE PERIOD OF JULY 31 THROUGH SEPTEMBER 15 OF EACH YEAR.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGTHIETH of one cubic foot per second or the equivalent for each acre irrigated, and shall further be limited to a diversion not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to correct a scrivener's error in Certificate 80763 that was issued to confirm the right modified by provisions of an order recorded at Special Order Volume 60, Page 205, diminishing the water right evidenced by Certificate 76472. This certificate corrects and supersedes Certificate 80763.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
