## CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO

CHAMBERLAIN DITCH COMPANY 75282 UPPER DIAMOND LANE WALLOWA OREGON 97885

confirms the right to use the waters of BEAR CREEK, a tributary of the WALLOWA RIVER, for DOMESTIC, STOCK USE and IRRIGATION of 1226.40 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for WALLOWA County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 5, at Page 151, 152, 153 and 154. The dates of priority are 1883 for Tracts 1, 2 and 3; and 1893 for Tracts 4, 5, 6, 7, 8, 9, 10, 11, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, and 30.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.5 acre-feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1.0 acre foot per acre during the entire remainder of the irrigation season.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
