CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MILES LEE AND E A VAN SICKLIN BAKER CITY OREGON 97814

confirms the right to use the waters of PINE CREEK, a tributary of the POWDER RIVER, for IRRIGATION OF 726.91 ACRES.

This right was perfected under Permit 410. The date of priority is AUGUST 22, 1910. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 9.19, being 9.09 CUBIC FEET PER SECOND FOR IRRIGATION and 0.10 CUBIC FOOT PER SECOND FOR DOMESTIC USE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE¼ NE¼, SECTION 26, T 8 S, R 38 E, W.M..- DRY GULCH DITCH

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
