CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NORTHWEST JOINT STOCK LAND BANK PORTLAND, OREGON

confirms the right to use the waters of TUMALUM RIVER, a tributary of COLUMBIA RIVER, for IRRIGATION OF 24.86 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 12, at Page 9. The date of priority is 1906.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1% miner's inches per acre or its equivalent in case of rotation, measured at the point of diversions from the source.

The point of diversions are located as follows:

TRACT #1 - SE% NE%, SECTION 24, T 6 N, R 35 E, W.M.; 1660 FEET SOUTH AND 1360 FEET EAST FROM N% CORNER, SECTION 35.

TRACT #2 - NE% NE%, SECTION 24, T 6 N, R 35 E, W.M.; 915 FEET SOUTH AND 1420 FEET EAST FROM N% CORNER, SECTION 35.

A description of the place of use to which this right is appurtenant is as follows:

The issuance of this certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
