confirms the right to use the waters of LOST RIVER AND TRIBUTARY STREAMS, tributary to TULE LAKE, for IRRIGATION of 371.6 ACRES IN TRACT 1 AND IRRIGATION OF 190.3 ACRES IN TRACT 2.

This right was confirmed by decree of the Circuit Court of the State of Oregon for KLAMTH County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Special Order Volume 7 at Page 147. The date of priority is 1902.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 7.02 cubic feet per second, or its equivalent in case of rotation, measured at the point of diversion.
