## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LEONARD E. FRICK, TRUSTEE, ET-AL P.O. BOX 3305 KERBY, OREGON 97531

confirms the right to use the waters of ILLINOIS RIVER, a tributary of ROGUE RIVER, for SUPPLEMENTAL IRRIGATION OF 1.0 ACRES.

This right was perfected under Permit 26436. The date of priority is NOVEMBER 3, 1959. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.02 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 5 (SE1/4 SW1/4), SECTION 9, T 39 S, R 8 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3½ acre-feet for each acre irrigated during the irrigation season of each year, PROVIDED FURTHER THAT THE RIGHT TO THE USE OF WATER IS LIMITED TO THE PERIOD WHEN THE FLOW OF WATER IN THE ILLINOIS RIVER IS 80 CFS OR MORE AT ITS MOUTH AND THE FLOW OF THE ROGUE RIVER IS 735 CFS OR MORE AT ITS MOUTH.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
