## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NORTH UNIT IRRIGATION DISTRICT 2024 NW BEECH STREET MADRAS, OR 97741

confirms the right to use the waters of DESCHUTES RIVER AND WICKIUP RESERVOIR constructed under Permit R-1677, and HAYSTACK RESERVOIR constructed under Permit R-1754, tributaries of the COLUMBIA RIVER, for IRRIGATION of 26.8 ACRES.

This right was perfected under Permit S-23196. The date of priority is February 28, 1913. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.59 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the points of diversion from the sources and is further limited to a maximum of 140.7 ACRE-FEET.

The points of diversion are located as follows:

Deschutes River - SE% NE%, SECTION 29, TOWNSHIP 17 SOUTH, RANGE 12 EAST, W.M.; 1,700 FEET SOUTH AND 730 FEET WEST FROM THE NE CORNER OF SECTION 29;

Wickiup Reservoir - SW% NE%, SECTION 7, TOWNSHIP 22 SOUTH, RANGE 9 EAST, W.M; and

Haystack Reservoir - SW% NE%, SECTION 27, TOWNSHIP 12 SOUTH, RANGE 13 EAST, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its

equivalent) and 5 % acre-feet per acre for each acre irrigated during the irrigation season of each year, and is further subject to the terms and conditions of the State Engineer's Order dated January 20, 1955 and February 4, 1955.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW% NW% 10.2 ACRES SW% NW% 16.6 ACRES SECTION 21

TOWNSHIP 9 SOUTH, RANGE 14 EAST, W.M.

When required by the Department, the water user shall install and maintain a headgate, and in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm an Allocation of Conserved Water approved by an order of the Water Resources Director entered FEBRUARY 4, 2004, and recorded in Special Order Volume 59, pp. 184-194.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining minimum instream flows.
