CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WELL NO.'S 1, 2, 3 AND 5 in the FORT ROCK BASIN for IRRIGATION OF 629.1 ACRES.

This right was perfected under Permit G-9261. The date of priority is DECEMBER 18, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 7.86 CUBIC FEET PER SECOND(CFS); BEING 1.48 CFS FROM WELL NO. 1, 2.23 CFS FROM WELL NO. 2, 2.56 CFS FROM WELL NO. 3, AND 1.59 CFS FROM WELL NO. 5, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL NO. 1 - SE 1/4 SE 1/4, SECTION 1, TOWNSHIP 25 SOUTH, RANGE 17 EAST, W.M.; 960 FEET NORTH AND 1100 FEET WEST FROM THE SE CORNER OF SECTION 1;

WELL NO. 2 - NW 1/4 NE 1/4, SECTION 18, TOWNSHIP 25 SOUTH, RANGE 18 EAST, W.M.; 60 FEET SOUTH AND 1330 FEET WEST FROM THE NE CORNER OF SECTION 18;

WELL NO. 3 - SE 1/4 NW 1/4, SECTION 7, TOWNSHIP 25 SOUTH, RANGE 18 EAST, W.M.; 1700 FEET SOUTH AND 2930 FEET WEST FROM THE NE CORNER OF SECTION 7;

WELL NO. 5 - NE 1/4 SE 1/4, SECTION 2, TOWNSHIP 25 SOUTH, RANGE 17 EAST, W.M.; 650 FEET SOUTH AND 1130 FEET WEST FROM THE EAST 1/4 CORNER OF SECTION 2.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
