CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SUCCESSORS TO
SQUAW CREEK IRRIGATION COMPANY

confirms the right to use the waters of SQUAW CREEK, a tributary of the DESCHUTES RIVER, for IRRIGATION of 658.8 ACRES and DOMESTIC USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 1, at Page 471. The date of priority is November 1904.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 13.18 cubic feet per second or the equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FIFTIETH of one cubic foot per second, or the equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



This certificate describes that portion of the water right described by Certificate 75878, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered SEP 08 2004, and recorded in Special Order Volume 61, Page 320, canceling a portion of the water right. This certificate supersedes Certificate 75878.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitation in said decree.
