CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

the Reed Institute of 3203 S.E. Woodstock Blvd., Portland, Oregon 97202 SUPERSEDED BY CERT. NO. 89200

confirms the right to use the waters of Crystal Springs Creek and Reed Reservoir constructed under permit R-4658, tributaries of JOHNSON CREEK, for irrigation of 31.5 acres.

The right was perfected under permit 30846. The date of priority is August 13, 1965. This right is limited to 0.254 cfs, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

SOUTH DIVERSION (REED RESERVOIR) - NE 1/4 SW 1/4 Section 13, T1S, R1E; 10 feet south and 1,390 feet west of the NE comer of Llewellyn DLC 49 WM.

NORTH DIVERSION (REED RESERVOIR) – NE 1/4 SW 1/4 Section 13, T1S, R1E; 290 feet north and 1,580 feet west of the NE corner of Llewellyn DLC 49 WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to $1/124^{th}$ of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 1.9 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed a duty of 1.9 acre-feet/acre at the point of diversion.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

This certificate confirms the remaining portion of the existing water right evidenced by Certificate 44544 and the reduction in the rate of diversion and transfer of lands approved by an Order entered July 13, 2000, in Volume 54, Page 524 Special Order Records of the Water Resources Department, approving Allocation of Conserved Water Application #8 and supersedes Certificates 44544 and 80468, State Record of Water Right Certificates.

The issuance of this certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows and is subject to all other terms and conditions of the original certificate.

The following conditions shall be included in this right:

- A. The point of diversion shall be metered to the satisfaction of the Watermaster.
- B. The point of diversion shall be screened to the specifications of the Oregon Department of Fish and Wildlife.
- C. An approved device to measure outflow shall be maintained.
- D. A record of the amount of water used each month shall be kept and submitted to the Department annually in accordance with OAR 690 Division 85.

E. These rights may be used in rotation with stored water under certificate 44545. The rotation shall be in accordance with an agreement filed with and acceptable to the Watermaster. This condition shall not limit the ability of the water right holder to enter into any other rotation allowed by law.
