CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EVA M. BELSHAW
JOHN DAY, OREGON 97845

confirms the right to use the waters of the JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 78.8 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for GRANT COUNTY. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461. The date of priority is 1865.

The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed ONE-FORTIETH of one cubic foot per second per acre, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

ENTERPRISE DITCH - NW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 20, T 13 S, R 31 E,
W.M..

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre irrigated from April 1 to September 30; further limited to 1 acre-foot per calendar month to July 1; and $\frac{1}{4}$ acre-foot per acre thereafter; total 5.0 acre-feet per acre for the season, measured at the point of diversion.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE $\frac{1}{4}$ SW $\frac{1}{4}$ 26.1 ACRES
SECTION 19

NE $\frac{1}{4}$ NW $\frac{1}{4}$ 40.0 ACRES
SE $\frac{1}{4}$ NW $\frac{1}{4}$ 12.7 ACRES
SECTION 30

TOWNSHIP 13 SOUTH, RANGE 31 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 51511, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered OCT 25 2004, approving Transfer Application 8813.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
