CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES AND SHIRLEY HEATER 4672 DRIFT CREEK ROAD SE SUBLIMITY, OREGON 97385

confirms the right to use the waters of WELLS 1, 2, AND 3, in the BEAVER CREEK BASIN for SUPPLEMENTAL IRRIGATION OF 164.1 ACRES.

This right was perfected under Permit G-10629. The date of priority is JUNE 18, 1986. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 1.321 CUBIC FEET PER SECOND (IF AVAILABLE AT THE ORIGINAL POINT OF APPROPRIATION DESCRIBED AS WELL 2), or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

WELL 1 - SE% SW%, AS PROJECTED WITHIN FINE DLC 59, SECTION 14, T 8 S, R 1 W, W.M.; 630 FEET NORTH AND 1620 FEET EAST FROM THE SW CORNER OF DLC 59;

WELL 2 - SE% SW%, AS PROJECTED WITHIN FINE DLC 59, SECTION 14, T 8 S, R 1 W, W.M.; 620 FEET NORTH AND 730 FEET EAST FROM THE SW CORNER OF DLC 59; AND

WELL 3 - SE¼ SW¼, AS PROJECTED WITHIN FINE DLC 59, SECTION 14, T 8 S, R 1 W, W.M.; 780 FEET NORTH AND 480 FEET EAST FROM THE SW CORNER OF DLC 59.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The water user shall install in-line flow meters or other suitable devices for measuring and recording the quantity of water used. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate describes that portion of the water right confirmed by Certificate 80789, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered 007.25.2004, approving Transfer Application T-9407.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
