CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICHARD SPANGLER
ROUTE 1, BOX 339
FOREST GROVE, OREGON 97116

confirms the right to use the waters of A RESERVOIR CONSTRUCTED UNDER APPLICATION R-26220, PERMIT R-1232, a tributary of WEST DAIRY CREEK, for SUPPLEMENTAL IRRIGATION OF 60.0 ACRES.

This right was perfected under Permit 20602. The date of priority is JULY 20, 1951. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 4.4 ACRE FEET or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

SE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 3, T 1 N, R 4 W, W.M..

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of the equivalent to 2.5 acre-feet per acre for each acre irrigated during the irrigation season and shall be further limited to a total of not to exceed 4.4 acre feet in any one irrigation season.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
