CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM AND FLORENCE HOWELL
P.O. BOX 151
IMBLER, OREGON 97841

confirms the right to use the waters of GRANDE RONDE RIVER AND OLD CHANNEL GRANDE RONDE RIVER RESERVOIR, CONSTRUCTED UNDER PERMIT R-7844, a tributary of SNAKE RIVER, for IRRIGATION of 167.4 acres.

This right was perfected under Permit 44320. The date of priority is JUNE 15, 1979. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 2.0 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

NW¼ NW¼, SECTION 28, T 1 S, R 39 E, W.M.; 720 FEET SOUTH AND 50 FEET EAST; PUMP LOCATED - 1380 FEET SOUTH AND 1600 FEET EAST BOTH FROM NW CORNER OF SECTION 28.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 58084, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered MAR 24 2005, approving Transfer Application 9546.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
