CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

OREGON BERRY PACKING COMPANY ROUTE 6, BOX 224 HILLSBORO, OREGON 97123

confirms the right to use the waters of A WELL in the CHRISTENSEN CREEK BASIN for the purpose of IRRIGATION OF 33.7 ACRES.

This right has been perfected under Permit G-8585. The date of priority is MAY 7, 1979. This right is limited to 0.42 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 1/4 NW 1/4, AS PROJECTED WITHIN C. LEWIS DLC 51, SECTION 31, TOWNSHIP 1 SOUTH, RANGE 2 WEST, W.M.; 450 FEET SOUTH AND 2650 FEET EAST FROM NW CORNER OF SECTION 31.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
