CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LES SCHWAB TIRE CENTERS OF OREGON

confirms the right to use the waters of PETERSON CREEK RESERVOIR ENLARGED UNDER PERMIT R-5479, a tributary of NORTH FORK CROOKED RIVER, for SUPPLEMENTAL IRRIGATION OF 180.0 ACRES.

This right was perfected under Permit 34405. The date of priority is NOVEMBER 17, 1969. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 16.5 ACRE-FEET STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

RESERVOIR - SE 1/4 SE 1/4, SECTION 12, TOWNSHIP 14 SOUTH, RANGE 22 EAST, W.M.; 130 FEET NORTH AND 680 FEET WEST FROM THE SE CORNER OF SECTION 12; AND

PETERSON CREEK RE-DIVERSION - SE 1/4 SE 1/4, SECTION 12, TOWNSHIP 14 SOUTH, RANGE 22 EAST, W.M.; 1000 FEET WEST FROM THE SE CORNER OF SECTION 12.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

A description of the place of use to which this right is appurtenant is as follows:

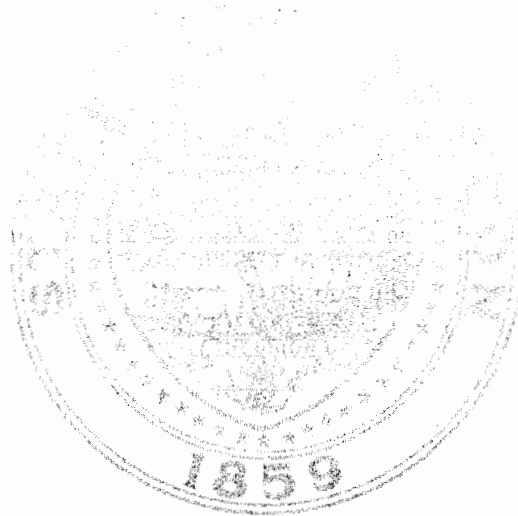
TOWNSHIP 14 SOUTH, RANGE 21 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
