## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

R & R COUSSENS INVESTMENTS INC 8200 NW GLENCOE ROAD HILLSBORO, OREGON 97124

confirms the right to use the waters of MCKAY CREEK tributary of DAIRY CREEK, for IRRIGATION OF 5.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 53.9 ACRES.

This right was perfected under Permit S-22120. The date of priority is FEBRUARY 11, 1953. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.75 CUBIC FOOT PER SECOND (CFS), BEING 0.07 CFS FOR IRRIGATION AND 0.68 CFS FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
