## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELIZABETH BRADY AND JOHN H. JACOBSON 7130 SMULLIN ROAD MT. HOOD, OREGON 97041

confirms the right to use the waters of YELLOW JACKET CREEK, EAST FORK OF HOOD RIVER, and RESERVOIR 1, a tributaries of HOOD RIVER, for IRRIGATION of 17.5 acres.

This right was perfected under Permit 47448. The date of priority is JULY 12, 1982. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 0.218 CUBIC FOOT PER SECOND, from Yellow Jacket Creek with any deficiency to be supplied by East Fork Hood River and Reservoir 1, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

- POD 1 (YELLOW JACKET CREEK) SW% NE%; SECTION 9, T 1 S, R 10 E, W.M.; 780 FEET NORTH AND 1865 FEET WEST FROM THE E% CORNER OF SECTION 9;
- POD 2 (RESERVOIR 1) NE% NW%; SECTION 9, T 1 S, R 10 E, W.M.; 450 FEET SOUTH AND 850 FEET WEST FROM THE NORTH % CORNER OF SECTION 9;
- POD 3 (EAST FORK HOOD RIVER) NW% NW%, SECTION 9, T 1 S, R 10 E, W.M; 165 FEET SOUTH AND 455 EAST FROM THE NORTHWEST CORNER OF SECTION 9;
- POD 4 (EAST FORK HOOD RIVER) NW% SW%, SECTION 4, T 1 S, R 10 E, W.M; 1020 FEET SOUTH AND 2140 FEET WEST FROM THE CENTER CORNER OF SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
