CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the POISON CREEK SLOUGH BASIN for PRIMARY IRRIGATION OF 20.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 23.0 ACRES.

This right was perfected under Permit G-9805. The date of priority is JULY 9, 1981. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.54 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 1/4 SE 1/4, SECTION 1, TOWNSHIP 23 SOUTH, RANGE 31 EAST, W.M.; 1920 FEET NORTH AND 250 FEET WEST FROM THE SOUTHEAST CORNER OF SECTION 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
