CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICHARD C. WEAVER
HCR 56, BOX 570
JOHN DAY, OREGON 97845

confirms the right to use the waters of JOHN DAY RIVER, a tributary of COLUMBIA RIVER, for the purpose of IRRIGATION OF 3.19 ACRES, LIVESTOCK AND GREENHOUSE.

This right has been perfected under Permit 43318. The date of priority is APRIL 24, 1978. This right is limited to 0.086 CUBIC FOOT PER SECOND(CFS); BEING 0.08 CFS FOR IRRIGATION, 0.005 CFS FOR LIVESTOCK AND 0.001 CFS FOR GREENHOUSE or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SW 1/4, SECTION 20, TOWNSHIP 13 SOUTH, RANGE 31 EAST, W.M.;
1700 FEET NORTH AND 1700 FEET EAST FROM THE SW CORNER OF SECTION 20.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 5.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.



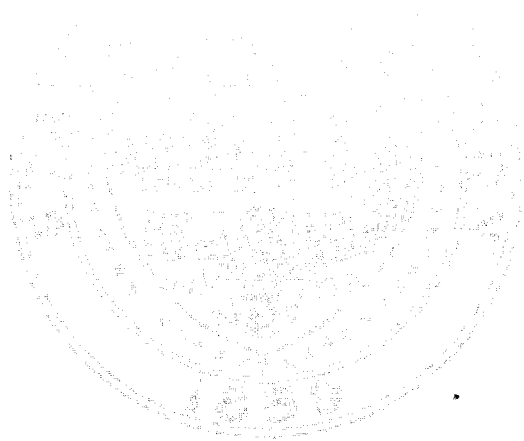
A description of the place of use under this right, and to which this right is appurtenant, is as follows:

SW 1/4 NW 1/4 3.19 ACRES, LIVESTOCK AND GREENHOUSE
SECTION 25
TOWNSHIP 13 SOUTH, RANGE 30 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
