## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN C. SUSBAUER, ET.AL. 3000 NW CORNELIUS-SCHEFFLIN ROAD CORNELIUS, OREGON 97113

confirms the right to use the waters of DAIRY CREEK, a tributary of the TUALATIN RIVER, for IRRIGATION OF 19.5 ACRES AND SUPPLEMENTAL IRRIGATION OF 45.2 ACRES.

This right was perfected under Permit S-20846. The date of priority is NOVEMBER 5, 1951. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.80 CUBIC FOOT PER SECOND (CFS), BEING 0.24 CFS FOR IRRIGATION AND 0.56 CFS FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
