## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SOPHIA DELASHMUTT TRUST 5185 NW CORNELIUS-SCHEFFLIN ROAD CORNELIUS, OREGON 97113

confirms the right to use the waters of DAIRY CREEK AND AN UNNAMED STREAM AND RESERVOIR CONSTRUCTED UNDER PERMIT R-1994, tributaries of the TUALATIN RIVER, for IRRIGATION OF 25.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 27.2 ACRES.

This right was perfected under Permit S-24722. The date of priority is JANUARY 2, 1957. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.31 CUBIC FOOT PER SECOND (CFS) FOR IRRIGATION, BEING 0.18 CFS FROM DAIRY CREEK AND 0.13 CFS FROM AN UNNAMED STREAM AND 0.34 CFS FOR SUPPLEMENTAL IRRIGATION, BEING 0.19 CFS FROM DAIRY CREEK AND 0.15 CFS FROM AN UNNAMED STREAM, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-1994.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
