CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of DAIRY CR AND UNNAMED CR AND UNNAMED RESERVOIR CONSTRUCTED UNDER PERMIT R-1358, a tributary of the TUALATIN R AND DAIRY CREEK, for IRRIGATION OF 1.0 ACRE AND SUPPLEMENTAL IRRIGATION OF 9.2 ACRES.

This right was perfected under Permit S-21235. The date of priority is JANUARY 30, 1951. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.13 CUBIC FOOT PER SECOND (CFS), BEING 0.01 CFS FOR IRRIGATION, BEING 0.007 CFS FROM DAIRY CREEK AND 0.003 CFS FROM UNNAMED CREEK AND RESERVOIR; AND 0.12 CFS FOR SUPPLEMENTAL IRRIGATION, BEING 0.08 CFS FROM DAIRY CREEK AND 0.04 CFS FROM UNNAMED CREEK AND RESERVOIR, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-1358.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
