PB FARMS INCORPORATED P.O. BOX 69 NORTH POWDER, OR 97867

confirms the right to use the waters of NORTH POWDER RIVER, a tributary of POWDER RIVER, for IRRIGATION of 117.0 acres, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UNION COUNTY County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 3, at Page 252. The date of priority is 1884 for irrigation of 37.0 acres and 1870 for irrigation of 80.0 acres.

The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed 2.93 CUBIC FEET PER SECOND (cfs) from March 1 to June 30 and 1.46 cfs from July 1 to October 1 of each year; the total quantity diverted during each irrigation season not to exceed 292.5 acre-feet.

The point of diversion is located as follows:

NE¼ SE¼, Section 28, Township 6 South, Range 39 East, W.M.; Lun Ditch - 2,600 feet North and 440 feet West from the SE Corner of Section 28.
