CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LOST AND BOULDER DITCH CO.
 P.O. BOX 12

confirms the right to use the waters of LOST AND BOULDER CREEKS, tributaries of the WHITE RIVER for IRRIGATION OF 533.95 ACRES, DOMESTIC, AND STOCK USE FOR TRACT 1, AND DOMESTIC FOR TRACT 3.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wasco County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7 and 11, at Pages 196 and 416, respectively. The date of priority is 1901 FOR TRACTS 1 AND 3.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 6.98 CUBIC FEET PER SECOND (CFS), FOR TRACTS 1 AND 3, measured at or near the diversion box at the head of the main laterals of said company situated in the NE¼ SW¼, SECTION 10, T 5 S, R 11 E, W.M.

This certificate describes that portion of the water right confirmed by Certificate 80559, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director recorded in Special Order Volume 63, Page 166, approving ALLOCATION OF CONSERVED WATER application C-35 and together with Certificate 81470 (the conserved water remaining right for Tract 2), and Certificate 81336 (the instream right created by the allocation of conserved water) supercedes Certificate 80559, State Record of Water Right Certificates.

The issuance of this superceding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
