The right to store and use these waters was perfected under Reservoir Application R-80898. The date of priority is January 1, 1993. The amount of water entitled to be stored and used each year under this right is not more than 2.3 ACRE-FEET, BEING 0.4 AF EACH IN RES 1, 2, 4, 5, 6, 0.3 AF IN RES 3.


