CERTIFICATE OF WATER RIGHT

confirms the right to store the waters of MOOREHOUSE CREEK AND THREE UNNAMED STREAMS, tributaries of the LITTLE NORTH FORK SANTIAM RIVER, in RESERVOIR A ENLARGEMENT AND RESERVOIRS 1 THROUGH 7, appropriated and maintained under Permit 37778, for IRRIGATION AND AESTHETIC USES.

The right to store these waters was perfected under Reservoir Permit R-6116. The date of priority is FEBRUARY 26, 1974. The amount of water entitled to be stored each year under this right is not more than 11.17 ACRE-FEET (AF); BEING 1.75 AF IN RESERVOIR A, 2.4 AF IN RESERVOIR 1, 0.34 AF IN RESERVOIR 2, 1.23 AF IN RESERVOIR 3, 0.36 IN RESERVOIR 4, 3.17 AF IN RESERVOIR 5, 1.56 AF IN RESERVOIR 6, AND 0.36 AF IN RESERVOIR 7.
